Composition, information on ingredients

The product is composed of continuous glass filaments above 3 microns in diameter. They consequently do not reach the lower respiratory tract and therefore have no possibility of causing serious pulmonary disease. Can contain other minor ingredients (coating, sizes etc).

Section 4 - First Aid Measures

Inhalation

If inhaled remove affected person from contaminated area. Keep at rest until recovered. If symptoms develop and/or persist seek medical attention.

Ingestion

Do not induce vomiting. Wash out mouth thoroughly with water. Seek immediate medical attention.

Skin

Wash affected area thoroughly with soap and water. If symptoms develop seek medical attention.

Eve

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses. Continue flushing for several minutes until all contaminants are washed out completely. If symptoms develop and/or persist seek medical attention.

Suitable Extinguishing Media

Carbon dioxide, powder or water spray. Fight larger fires with water spray or alcohol resistant foam.

Specific hazards arising from the chemical

Glass filaments are not flammable or combustible and do not support combustion. Only the packaging (plastic film, paper, cardboard, wood) and minor ingredients are combustible.

Can start to decompose >200 °C

Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers.

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Collect the material and place into a suitable labelled container. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Section 7 - Handling and Storage

Precautions for Safe Handling

Avoid exposure. Use only in a well ventilated area. Keep containers tightly closed. Prevent the build up of dusts in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Ensure that storage conditions comply with applicable local and national regulations.

Engineering Controls

Provide sufficient ventilation to keep airborne levels as low as possible. Where dusts are generated, particularly in enclosed areas, and natural ventilation is inadequate, a local exhaust ventilation system is required.

Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable dust filter should be used. Reference should be made to Australian Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

Eye and Face Protection
