Section 6 - Accidental Release Measures

Emergency Procedures

Remove all sources of ignition. Increase ventilation. Evacuate all unprotected personnel. Wear respiratory protection and full protective clothing to minimise exposure to dust or fibre. Collect the material and place into a suitable labelled container. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations

Section 7 - Handling and Storage

Precautions for Safe Handling

Avoid inhalation of loose fibre/dust, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of loose fibre/dust in the work atmosphere. Establish good housekeeping practices. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a well ventilated area away from heat and sources of ignition, out of direct sunlight and moisture. Take precautions against static electricity discharges. Use proper grounding procedures. Store away from incompatible materials such as materials that support combustion (oxidising materials). Store away from petrochemicals. Store in suitable, labelled containers. Have appropriate fire extinguishers available in and near the storage area. Ensure that storage conditions comply with applicable local and national regulations.
